9. All applicants seeking Recognition of Prior Learning (RPL) will incur a cost of \$125.00 per unit.
10. If applicant is eligible for **RPL or Credit Transfer**, the qualification price will be adjusted & a new student fee is determined.

12. Issuance of certificates is subject to full payment of course and materials fees.
13. Payment of course fees does not guarantee successful completion and certificate issue for the course.
