- Student Fees are currently applicable to Entitlement Full Qualifications and Targeted Priorities Full Qualifications. The fees as per the schedule are indicative. Actual fees are calculated using the online 'Smart & Skilled Provider Calculator' and reflected in the statement of fees at the enrolment stage.
- Students enrolling into the Entitlement A&T program stream can access fee-free training where the applicant meets the eligibility criteria.
- Tuition fee charges are divided up proportionally across each individual unit of competency. Credit Transfers are fee exempt.
- iTFE charge an Enrolment Fee on Fee for Service training, this covers administrative costs to process enrolments and is non-refundable (for more information, refer to our Fees and Refunds Policy).
- Fee Exemptions : Eligible Aboriginal students are entitled to fee-free government subsidised training in priority skill areas  
  
Students with a disability and eligible students who are dependants of Disability Support Pension recipients are exempt from fees for any Smart and Skilled training they undertake.
